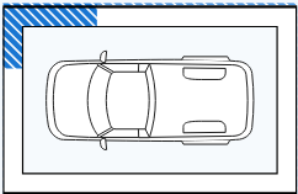

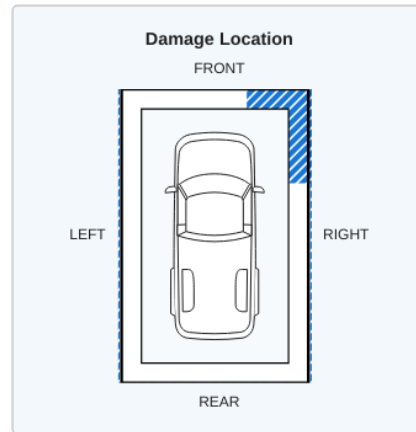

### Commercial
